Consequent on acquittal & dropping of disciplinary proceedings against Sri Ch. Venkateswara Rao, Divisional Accounts Officer (W) Gr-II (Retd.) and regularization of suspension period from 06-12-2001 to 27-01-2004 and dismissal period from 18-05-2007 to 30-11-2012 as "on duty" under F.R.54-A(3), as per the Government orders 1st cited, the individual has represented to consider his promotion as Divisional Accounts Officer (W) Gr-I on par with his junior Sri J.S. Prasad, Divisional Accounts Officer (W) Gr-II w.e.f.30-11-2005.

As per the Director of Works Accounts, Andhra Pradesh orders vide Procd.No.DWA/Hyd/Sn-I/A1/2005-06/346 Dt.30-11-2005, Sri J.S. Prasad, Divisional Accounts Officer (W) Gr-II who is junior to Sri Ch. Venkateswara Rao, Divisional Accounts Officer (W) Gr-II was promoted as Divisional Accounts Officer (W) Gr-I w.e.f 30-11-2005 and due to pendency of disciplinary proceedings against Sri Ch. Venkateswara Rao, Divisional Accounts Officer (W) Gr-II, his promotion to DAO-Gr-I was not considered at that time.

The Government vide reference 3<sup>rd</sup> cited have issued directions to examine consideration of the notional promotion of Sri Ch. Venkateswara Rao, Divisional Accounts Officer (W) Gr-II(Rtd) on par with his junior Sri J.S. Prasad who was promoted as Divisional Accounts Officer (W) Gr-I on 30-11-2005.

In this regard, as per Rule 24 of Telangana State and Subordinate Service Rules, 1996 "any order of revision likely to affect a person who has already been appointed from such panel, shall be given an opportunity of making his representation against the proposed revision, before any order of revision is passed".

Accordingly, all the individuals empanelled for promotion to the post of Divisional Accounts Officer (W) Gr-I in the panel year 2005-06 are hereby informed that they may submit objections, if any, on the proposed revision within 15 days from the date of issue of this Memo. If no objections are received within 15 days, it will be presumed that there are no objections on the proposal and further action will be initiated. Representations received beyond the stipulated period will not be entertained.
